- Two new staff members will begin over the summer.
- Mr. Stephens shared the location of the natural gas line. The Township building inspector was
  consulted and advised against the construction of an additional door in the currently proposed
  location. Mr. Stephens will meet with Mr. Bagnati and Mr. Stewart to further review and discuss.
- The library has secured a new firm to provide legal services. Their fee is \$55 more per hour than the previous counsel's rate.
- There were 450 surveys returned by the community. Mr. Stephens will reach out to set up meetings with individual trustees to discuss the library's strategic plan.
- The legacy project is progressing. There are grants available for digital literacy that may be applied for.
