- The Township is actively considering a new health insurance provider. Currently the Township employees participate in the State Health Benefits plan. The Township administrator has begun to research other providers and is considering the North Jersey Health Insurance Fund. The benefits would be very similar to the current plan, however, the contributions would be less than they are currently. A representative from the fund will be at the municipal building tomorrow to answer questions from the library staff.
